

1 Editorial

2 The NIS-NEST project news: The NIS-NEST FP7 Information Day and Workshop in Belarus

An FP7 information day followed by an FP7 workshop aiming to practical advice on proposal preparation & project management, and support the participation of the scientific community in FP7, *was* realized in Belarus (Minsk) on 28-29 February 2008.

During the FP7 information day, representative from the INCO Unit of the European Commission, Mr Genovese delivered presentation on FP7 and opportunities for participation of Belarusian researchers and Mr Klaus Pendl, representative from the ICT Unit of the European Commission, delivered presentation on Belarus – EU ICT collaboration opportunities. The Coordinator of FP7 Contacts in Belarus as well as representative from the Idealist7fp project supported and delivered relevant presentations. Belarusian researchers- partners in FP6 funded projects presented their experience of collaboration with scientists from EU countries and highlighted the advantages of Belarus- EU collaboration in FP7. During the FP7 workshop, most of the participants had previous experience of participation in the Framework Programmes and expressed considerable interest in collaboration with EU scientists and research organizations from EU Member States within FP7 as well.
